The subject of the East Brothers
Light House was on the agenda of the
City Council on Tuesday night, February
12. Brought to their attention from two
sources; the West Side Improvement
Club and the Richmond Planning Commission, the Council side-stepped, and
passed the buck -- two tried-and-true
practices. Both organizations proposed
that the council pass a resolution favoring the retention of the historic lighthouse.
(The Coast Guard is planning to demolish
it).

The subject was placed on their "Consent Calendar" which meant that it would be turned over to the City Manager for study. A representative of the Contra Costa Shoreline Park Committee asked to speak on the subject, in an attempt to obtain a more definitive action, but was not given an opportunity to speak and the matter was passed on to the city manager for consideration. This is not a negative action, but it is also not positive. The City Council's support would give more strength to the requests being made to the Coast Guard to save the Light House.

Richard Baroni discussed the Light House with City Manager Kenneth Smith, who agrees that the Light House should be saved from demolition. The City of Richmond will not be likely to take on the responsibility of the Lighthouse, but you may contact Mr. Smith with your ideas. Most important, if you wish to help to save the Lighthouse, is the request directly to the Commandant of the United States Coast Guard, Washington, D.C., 20591.

ARTISTS are invited to paint pictures of the East Brothers Light House. The Contra Costa Shoreline Park Committee will arrange for display of the paintings, when they are submitted. More information will follow on dates, but start painting soon!

TOU CAN'T

There were not enough petitions signed to bring the subject of water fluoridation to a vote. ABOUT EAST BROTHER'S LIGHT HOUSE

The campaign now being waged by several local groups to preserve the East of Brother's Light House brings back memories of weekend trips to the lighthouse by some of us children of the Point. We would walk to the old Standard Oil carpenter shop and catch the train which carried the workers to the Can Factory located at Point Orient. We got off at Point San Pablo wharf where Bill Bailey, the wharfinger would grab his megaphone and call to the lighthouse. The two Stenmark boys, Phillip and Folke, would row in and pick us up.

The Stanmark family consisted of John O. Stenmark, Mrs. Stenmark, their two daughters Rubie and Annie and the two sons mentioned above. All are now deceased except Annie who is Mrs.

fished a lot, and would go for a row when the tide was slack or the Bay calm. It was very seldom that we played baseball, since every ball over the fence meant lowering the boat and rowing quite a distance plus a hard row back against the tide. Additional children from the Point who made visits to the island were Julia and Fred Neu and the late Robert Pickett and Bob Forrest who lived at the old Healy Tibbetts rock quarry, which was located at Point Molate. The Stenmark girls would give parties occasionally

Captain Stenmark was a native of Stockholm, Sweden, and became a mem ber of the Lighthouse Service as a reward for an act of bravery while employed as a sailor on the lighthouse tender "Madrona". Stenmark and a crew from the tender were attempting to get a boatload of supplies from the tender to Point Conception Lighthouse in a rough sea when the boat capsized. The assistant Chief Lighthouse Inspector, who was in the bow of the boat, was injured and carried seaward by the huge waves and the undertow. Stenmark, although bleeding from injuries managed to reach the inspector and sup-W port him until they were

was once each month, when the Tender arrive with supplies During his term there, he rescued several fishermen whe

their boats capsized, and as a reward, was placed in charge of the Brother's Island Lighthouse off Point San Pablo, where he remained for 20 years.

The family moved from the lighthouse to Richmond and owned and operated the Stenmark House of 15th Street for many years.

Captain Stenmark died on May 17, 1915, from a heart attack, while enroute from S. F. to Blunts Reef Lightship, onthe Coastal Steamer "City of Topeka". His remains were shipped from Eureka to Richmond, and funeral services were held May 20, 1915.
